Appendix 1 to the regulations in the BL 7-series (air routes etc.), Particular environmentally sensitive nature areas

Edition 2, 21 November 1985

In pursuance of § 82 and Subsection 8 of § 149 of the Air Navigation Act, cf. Consolidation Act no. 381 of 10 June 1969 as amended by Act no. 94 of 29 March 1972 and most recently by Act no. 87 of 13 March 1985, the Civil Aviation Administration - Denmark hereby lays down as follows on the authority of the Ministry of Public Works, cf. Order no. 93 of 8 March 1982:

1. The increasing extent of air traffic has caused more disturbance to birds and game during recent years. Many species of both birds and mammals are sensitive to noise from aircraft, and even a few overflights of bird and game resorts can be critical.

2. The most important resorts for birds and game in South Denmark are marked on page 3. Flights over these areas at altitudes below 1000 ft (300 m) shall be avoided.

3. Flights in Greenland over the areas 29, 30 and 31, cf. pages 4 and 5, at altitudes below 1500 ft (500 m) shall be avoided.
